Priest Itafa to my 1st message ).It was this feeling that was pressing upon my heart to share these few words of upliftment with my royal family as Jah touch my finger upon his golden pen, to propose;

Proposal of the Ethiopia Africa Black International Congress, head quarters and branches to fundamentally achieve our long over due aim and object; Freedom Redemption and International repatriation with universal reparation and compensation for all slave children and victims of colonialism, imperialism of the inhumane trans atlantic, seventeenth (17th) century African triangular slave trade at home and abroad . On the main land of continent mother Africa and the African diaspora scattered abroad globally.

**(1) - Communication net work**

I n I must communicate amongst our selves (with-in our region/precinct head quarters and braches)to stimulate and sensitize the minds of our people to an understanding of our aim and object. So as to formulate a clear plan of action in order to properly; (a) Form a method of approach (b) Strategize (c) Execution of our work House of Bobo under the auspices of the hon. Prophet Moambeh is a commendable tower of strength and paramount vehicular organ for progressive communication net work between E.A.B.I.C. members globally. Priest Basil Ingraham.

**(2)-Reconciliation council**

Reconciliation is a task of the priesthood and it calls for elder priest who have experience with dispute settlement and conflict resolution with a non bias approach. In a priestly reasoning with the hon. Priest Dougie he seem to hit the nail on the head when he said, ”when members have conflicts and no closure is brought to the conflict it leaves open wounds. Healing can only come after proper closure to these conflicts.” Dada taught us that; “ teeth and tongue may met, but just let your yea be yea and your nay be nay, cause the teeth need the tongue and the tongue need the teeth, so the teeth can not bite off the tongue nor the tongue push the teeth out the mouth”. In this time of lent temptation is great, fasting and praying is a must. After closure is brought to our in-house injustices regionally and internationally conflicts and strife and the healing process begins. I n I must follow Jah command, “together we walk, together we talk, together we wash one another feet, some people say that we have no need, but we doing the lords command. Laws and commandments of our father, father Moses , Jacob Abraham the Black Christ in flesh, Holy Emmanuel I Holy King Selassie I jah Rastafari.

### **(3)-Organization**

Organization in the E.A.B.I.C. H.Q. and branches is paramount to ensure no overlapping nor over stepping bounds of works of our aim and object. The time has now come in this era of African Redemption to embark upon a pragmatic plan of action to exercise and apply to reality what we have amassed through out the years of study (practice perfect) in Jerusalem School Room (spiritual and temporal) and execute the father's four point plan of repatriation. Calling on the Black man's Parliament to meet and fulfill Dada wishes, will and wonders. Thirty two (32) representatives from the head quarters and branch will be needed to fulfill this timely task. Our (R) parliament is our over site with Jah as our head to make thirty three (33). Representation in; (1) the house of (x) parliament where ever African people are globally (2) the house of Lords/ Privy council-(London England) (3) the United Nation's international court of justice-(New York U.S.A.) and the Hague in the Netherland. (4) the African Union (A.U.) – Addis Ababa Ethiopia Continue.....

E.A.B.I.C. representatives at the head quarters must continue to rally, lobby and agitate the Jamaica house of (x) parliament there is a seat for representation of Africans in the western world to have a voice in the O.A.U. now African Union. Granted by His Divine Majesty Emperor Haile Selassie on his historic state visit to Ja. In 1966 in honor of the great achievements the Rt Hon. Prophet Marcus Mossiah Garvey. Don't let it remain unoccupied brethren.

E.A.B.I.C. representatives in the U.S.A. must lobby at United Nation International Court of Justice.

E.A.B.I.C. representatives in the Netherland must lobby at Hague.

E.A.B.I.C. representatives in the crown head state of Ethiopia must lobby at the African Union in Addis Ababa.

E.A.B.I.C. representatives globally must lobby the Parliament where ever Africans dwell and wishes to return home.

E.A.B.I.C. representatives dwelling with –in the commonwealth of the Bahamas has led the way in the branches by commencing the lobbying process from 1991 and has reinstated our commitment to a coherent and consistent agitation for our divine rights to return home through due process of our aim and object. Lobbying the three (3) distinctive administrations with documents to prove.

Hon. Priest Rithmond McKinney lobbied the Sir Lynden O. Pingle (a former and deceased prime minister of Bahamas ). Also former Governor General of the commonwealth of the Bahamas Sir Clifford Darling was lobbied by Priest Rithmond during that same era. There are three(3) documented letters from (R) Gov. to (x) gov. from 1991 to 1992.

After the change of administration in 1992, shortly there- after on December 7th 1993 E.A.B.I.C. representatives address the Bahamas senate on matters pertaining to our aim and object . In March of 1994 E.A.B.I.C. representatives demonstrated, rallied youths and sensitize the public of our aim and object during Her Majesty Queen Elizabeth II state visit to her commonwealth of the Bahamas. The Bahamas gov. was also petitioned on March 24th 1994 Hon. Hubert A. Ingraham prime minister of the Bahamas was lobbied and served. On September 4th 1995 E.A.B.I.C. representatives met with the leader of the official Opposition of the Bahamas the Hon. Sir Lynden O. Pingle and later that same day paid a courtesy call on His Excellency Sir Orville Turnquest Governor General of the Bahamas. Sir Turnquest promise to assist our plight and kept

his promise in November 1997 by inviting His Excellency the Hon. Ethiopian Crown Prince Ermias Selassie as keynote speaker at the commonwealth heads of government, governor general's convention. I n I coordinated a public Rastafari ceremonial service, reasoning seminar and recommended Hon. Priest Rithmond McKinney an ambassador of the E.A.B.I.C. to receive a gold medal on behalf of all houses of Rastafari in the Bahamas.

At the end of former prime minister Hon. Perry G. Christie's reign in 2007 he also was petitioned by the E.A.B.I.C. Bahamas branch on the aim and object. These are only a few of the precedents and hall marks of our skillful agitation, rally and lobbying to heads of government for approximately two decades.

#### **(4)-Centralization**

Centralization is the watch word for the E.A.B.I.C. branches as taught by our father King Emmanuel who centralized all houses of Rastafari on march 1st 1958 at Back "o" Wall Kingston Jamaica with the inauguration of the E.A.B.I.C.. However this unity was brutally dispersed by Queen Elizabeth's brutal thugs; the police force. In one country there can only be one branch with many limbs. Limbs reaching out to members through communication net working to ensure cohesiveness in works. ( Give thanks for the works the Hon. Priest Campbell during the 49th anniversary of the E.A.I.B.C. at H.Q. to shine light on the situation of Ghana ,Kenya and other branches. Also the Hon. Priest Basil ( Nuckles ) Ingraham 50th anniversary booklet)

#### **(5)-Agitation**

Skillful Agitation should take place when all Qualified E.A.B.I.C. representatives globally are on one page in one sweet accord to avoid over lapping of works. Representatives should feel free to share with each other, documents, knowledge, updates and reports that should be filed in at H.Q. periodically to an over site committee. When communication net work, reconciliation, organization and centralization is achieved; registration becomes an integral part of skillful agitation to enable I n I to carry out our Father's mandate, e.g. if the E.A.B.I.C. was registered in Ethiopia 2002 when a delegation went from the Bahamas branch to Ethiopia with reverse-osmosis water purification system which was confiscated by the Ethiopian authority.

The Ghana situation is another ensample where the failure of communication, reconciliation, organization, centralization and agitation skillfully. New Tafo is in limbo, I n I pray for the peace of Jerusalem, peace with-in thy walls and prosperity with in thy palaces. Jah restore order, status , Quota and citizenship. Dada protocol stand. Jah want all branches and H.Q. registered in Ghana under the black 5 point star.

## **(6)-Reparation**

Reparation for the damages done to our mother land and our African ancestors is a process that takes careful research, planning and coordination. Which calls for our brightest minds to work together in one harmonious accord to achieve this paramount and enormous task.

## **(7)-Repatriation**

Universal reparation is not complete with out international repatriation. All heads of government are to be obedient to one man voice word sound and power, the I AM speaks through his 32 man Parliament, gathering 144,000 elected senators( the Hon. Priest Igo would say), to over see global repatriation to fulfill history and prophecy, every man return under his vine and fig tree, to bring forth a fundamental world peace.
